AMENDMENT TO SCHEDULE 8.

Schedule 8 to the Principal Order is amended by providing that the amounts appearing in Column 2 heading "Motor Spirit" subheading "Maximum Retail Selling Price" are increased by 2.0 toea per litre and that the amounts appearing in Column 3 heading "Distillate" subheading "Maximum Selling Price" are increased by 1.2 toea per litre.
