CONSTITUTION

Public Services Act (Chapter 67)

REVOCATION OF APPOINTMENTS AND PROMOTION AND APPOINTMENT OF DEPARTMENTAL HEADS

I, Tore Lokoloko, G.C.M.G., G.C.V.O., O.B.E., K.St.J., Governor-General, by virtue of the powers conferred by—

- (a) Section 193(3) of the Constitution and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council given after consultation with the Public Services Commission; and
- (b) Section 26 of the *Public Services Act* (Chapter 67) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council on the recommendation of the Public Services Commission; and
- (c) Section 57 of the *Public Services Act* (Chapter 67) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council on the recommendation of the Public Services Commission,

hereby—

- (d) revoke all previous appointments of Departmental Heads of the Department of the Public Services Commission, the Department of Defence, the Department of Education, the Department of Health and the Department of Lands and Surveys; and
- (e) promote and appoint Ekerome Age to the office of Secretary, Department of the Public Services Commission; and
- (f) promote and appoint Balthasar Maketu to the office of Secretary, Department of Defence; and
- (g) promote and appoint Geno Roakeina to the office of Secretary, Department of Education; and
- (h) promote and appoint Robert Quentin Reilly to the office of Secretary, Department of Health; and
- (i) promote and appoint Karipe Pitzz to the office of Secretary, Department of Lands and Surveys; and
- (j) appoint Wep Kanawi to the office of Secretary, Department of Industrial Development; and
- (k) appoint Paul Japhlom to the office of Secretary, Department of Physical Planning and Environment; and
- (l) appoint Leo Morgan to the office of Secretary, Department of Provincial Affairs.
