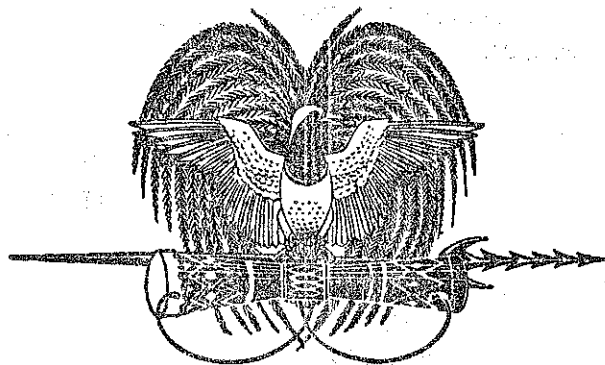

Organic Law on Provincial Government

APPOINTMENT UNDER SECTION 50
