Organic Law on National Elections

REVOCATION AND APPOINTMENT OF RETURNING OFFICERS

THE ELECTORAL COMMISSION, by virtue of the powers conferred by Section 18 of the Organic Law on National Elections and all other powers it enabling, hereby:—

- (a) revokes the appointment of Kala Rawali as Returning Officer for Wewak Open Electorate as contained in Notice of Revocation and Appointment of Returning Officers dated 4th October and published in the *National Gazette* No. G90 of 17th October, 1991; and
