PETITION

THE Humble Petition of Geoffrey Hughes (Export) Pty Ltd of 14th Level, South Tower, the Interchange, Corner Albert Avenue & Victor Street, P.O. Box 1790, Chatswood, N.S.W. 2067, Australia, sheweth as follows:—

1. Sitore Pty Ltd (hereinafter called the Company) was on the 30th day of November, 1992 incorporated under the *Companies Act*.
2. The registered office of the Company is not stated.

3. The nominal capital of the Company is K10 000 divided into 10 000 ordinary share of K1.00 each. The amount of capital paid up or credited as paid up is two.

4. The objects for which the Company was established are as follows:—

(a) To own and operate wholesale and retail outlets including wholesaling and retailing of beers, wines, distilled alcoholic beverages and including the operation of mobile wholesale and retail operations where permitted.

(b) To own and operate restaurants and other food outlets including the ownership and operation of licensed premises.

And other objects set forth in the Memorandum of Association therewith.

5. On the 25th day of April, 1997 default judgement was entered on the Company demanding payment of AUD\$50,322.00 plus interest.

6. As a result of the particulars specified in paragraph 5 hereof and by virtue of the Section 240 of the *Companies Act*, the said Company is deemed to be unable to pay its debts.

Your Petitioner therefore humbly prays as follows:—

(1) That the Company may be wound by the Court under the provisions of the *Companies Act*.

(2) That Chris J. Burt of Coopers & Lybrand, Chartered Accountants, 7th Floor, Mogoru Moto Building, Champion Parade, Port Moresby be appointed Liquidator.

(3) That the Petitioner be awarded the costs of instituting this Petition.

(4) That time for entry of this Order be abridged to the time of settlement by the Registrar.

(5) That such other order may be made in the Premises as shall be just.
