AUTHORIZATION OF PRESENCE IN THE COUNTRY OF AN INTERNATIONAL ASSISTANCE GROUP

DECLARATION OF AGREEMENT TO WHICH THE ACT APPLIES

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 4(1) of the *Bougainville (International Assistance Groups) (Privileges and Immunities) Act 1997*, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby declare that the Protocol concerning the Peace Monitoring Group made pursuant to the Agreement between Papua New Guinea, Australia, Fiji, New Zealand and Vanuatu concerning the Neutral Truce Monitoring Group for Bougainville done at Port Moresby on 5th December, 1997 is an Agreement to which the Act applies.
