- (a) Section 73(2A) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60A of the *Public Services (Management) Act 1995* and all other powers it enabling, in accordance with a recommendation from the West New Britain Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby revoke the appointment of Willie Edo as Acting Provincial Administrator for West New Britain Province dated 16th December, 2004 and published in the *National Gazette* No. G1 of 6th January, 2005; and
