THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by:—

- (a) Section 73(2A) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60A of the *Public Services (Management) Act 1995* and all other powers it enabling, in accordance with a recommendation from the Milne Bay Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby revoke the appointment of Henry Bailasi as Acting Provincial Administrator for Milne Bay Province; and
- (b) Section 73(2) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60 of the *Public Services (Management) Act 1995*, and all other powers it enabling, from a list of three persons submitted by the Milne Bay Provincial Executive Council from a list of persons recommended to the Provincial Executive Council by the Public Services Commission, following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby appoint Henry Bailasi as Provincial Administrator of Milne Bay Province for a period of four years,

with effect on and from 15th February, 2006.
