## DECLARATION TO PROHIBIT MOVEMENT OF COCOA PLANTS AND OTHER ALTERATE PLANTS OF THE ASIAN COCOA POD BORER FROM THE GAZELLE PENINSULA TO OTHER PARTS OF PAPUA NEW GUINEA

I, Mathew Siune, Minister for Agriculture and Livestock, by virtue of the powers conferred by Section 16 of the *Plant Disease and Control Act* (Chapter 220), and all other powers me enabling, hereby declare the prohibition of introduction of plant parts including seeds, branches and fruits of the following:—
