COMPULSORY ACQUISITION OF CUSTOMARY LAND BY THE MINISTER [STATE] BY 'SPECIAL REASON' PERSUANT TO SECTION 13(6) OF THE LAND ACT 1996

I, Hon. Sir Dr. Puka Temu, CMG, KBE, MP, the Minister for Lands & Physical Planning & Mining, by virtue of the powers conferred by Section 13(6) of the *Land Act 1996* and all other powers me enabling, hereby Compulsorily Acquire the area of the land held under customary tenureship described hereunder in the Schedule, notably doing away with the prerequisite to issue a 'Notice to Treat' before any acquisition is initiated/executed due to the Special Reason shown immediately hereunder.

SPECIAL REASON

I, as the Minister for Lands & Physical Planning, herein declare that the State intends to compulsory acquire the land described below in the Schedule for a 'Public Purpose'. The specific Public Purpose use is that the acquired area will be used for an industrial development purpose pursuant to clause (g) of the interpretation of public purpose provided for in the *Land Act 1996*.

Due to the urgency of the industrial developments needed in and around the subject area that is geared towards complementing the Government sanctioned Liquefied Natural Gas (LNG) Project, I, as Minister being aware of the time frame for the commencement of the project and realizing the need to have these industrial developments in place prior to the initial phases of the project herein exercise the power vested in me by the *Land Act 1996*.

It is also imperative to note that the said *Land Act 1996* also provides that "the interest of every person in land or a chattel to which a notice acquisition applies is, on the date of acquisition, converted into a right to compensation under this Act".
