Customs (Amendment) Act 2010

REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF COMMISSIONER OF PAPUA NEW GUINEA CUSTOMS SERVICE

I, Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3 of the *Customs (Amendment) Act 2010* and Sections 31A and 31B of the *Public Services (Management) Act 1995* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council on the recommendation of the Public Services Commission, hereby:—

- (a) revoke the appointment of Ray Paul as Acting Commissioner for Papua New Guinea Customs Services; and
- (b) appoint Ray Paul to be Commissioner for Papua New Guinea Customs Services for a period of five (5) years, with effect on and from 4th September, 2012.

Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty of VIP Cars on Customs Duty Exemption on the Airways imported vehicles as for the visit of His Royal Highness Prince Charles of Wales and The Duchess of Cornwall to Papua New Guinea as part of Her Majesty the Queen's Diamond Jubilee Celebrations from 3rd November, 2012 up to and including 5th November, 2012, with effect on and from the date of publication of this instrument in the *National Gazette*.
