AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Peter O'Neill, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 9th August, 2012 and published in *National Gazette* No. G304 on 10th August, 2012 in Schedule 29 (Minister for Works and Implementation)—

- (a) in Column 3 by adding the following new paragraph after Paragraph (a):
“(e) roads authority.”; and
- (b) by deleting the full stop in Paragraph (d), and substituting “; and”; and
- (c) in Column 4 by adding the following in alphabetical order:
“*National Roads Authority 2003*”.
