I, Peter O'Neill, CMG., Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 10th August, 2012 and published in *National Gazette* No. G304 of 10th August, 2012 (as amended):—

- (a) in Schedule 12 Minister for Higher Education, Research Science and Technology:—
 - (i) in Column 3 by deleting the following paragraph:
 - “(I) Institute of Medical Research”; and
 - (ii) in Column 4 by deleting the following:
 - “*Institute of Medical Research Act (Chapter 166)*, only Section 24(2) and (5).”; and
- (b) in Schedule 23 (Minister for Health and HIV AIDS):—
 - (i) in Column 3 by adding the following paragraph:
 - “(f) Institute of Medical Research”; and
 - (ii) in Column 4 by adding in alphabetical order the following:
 - “*Institute of Medical Research Act (Chapter 166)*, except Section 24(2) and (5).”.

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Peter O'Neill, CMG., Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 10th August, 2012 and published in *National Gazette* No. G304 of 10th August, 2012:—

- (a) in Schedule 10 (Minister for Religion, Youth and Community Development):—
 - (i) in Column 3 by deleting the paragraph (g); and
 - (ii) in Column 4 by deleting “*National Narcotics Control Board Act 1992*”; and
- (b) in Schedule 24 (Minister for Police):—
 - (i) in Column 3 by:—
 - (A) deleting the full stop in Paragraph (b) replacing it with “; and”; and
 - (B) adding the following new paragraphs after Paragraph (b):
 - “(c) *National Narcotics Control Board*; and”; and
 - “(d) *Security (Protection) Industry*.”; and
 - (ii) in Column 4:—
 - (A) in the *Second-Hand Dealers Act* (Chapter 322) by deleting “(all provisions except powers, functions, duties and responsibilities relating to second-hand clothing)”; and
 - (B) by adding the following in alphabetical order:
 - “*National Narcotics Control Board Act 1992*
 - “*Security (Protection) Industry Act 2004*”; and
- (c) in Schedule 23 (Minister for Health and HIV AIDS), in Column 4 by deleting “*Second-Hand Dealers Act* (Chapter 322) (the powers, functions, duties and responsibilities in relation to second-hand clothing only)”.
