APPOINTMENT OF ACTING PRIME MINISTER

I, Grand Chief Sir Michael Ogio, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 143(1)(c)(i) of the Constitution and Section 4(2)(c)(i) of the *Prime Minister and National Executive Council Act 2002*, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby appoint Patrick Pruaitch, a Minister, as Acting Prime Minister with effect on and from 8th June, 2014 up to and including 10th June, 2014 or until the Prime Minister resumes duty.
