REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF PROVINCIAL ADMINISTRATOR FOR EAST NEW BRITAIN PROVINCE

I, GRAND CHIEF SIR BOB DADAE, GCL., G.C.M.G., Governor-General, by virtue of the powers conferred by Section 73(2) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 61 of the *Public Services (Management) Act 2014*, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council after receiving recommendation from East New Britain Provincial Executive Council and the Ministerial Executive Appointment Committee, hereby—

- (a) appoint **Wilson Matava** as Acting Provincial Administrator for East New Britain Province for the following periods:—
- 15th February, 2016 to 14th May, 2016;
 - 15th May, 2016 to 14th August, 2016;
 - 15th August, 2016 to 14th November, 2016;
 - 15th November, 2016 to 14th February, 2017;
 - 15th February, 2017 to 14th May, 2017;
 - 15th May, 2017 to 14th August, 2017;
 - 15th August, 2017 up to and including 4th September, 2017; and
- (b) revoke the appointment of **Wilson Matava** as Acting Provincial Administrator for East New Britain province; and
- (c) appoint **Wilson Matava** as Provincial Administrator for East New Britain Province, for a period of four (4) years,

commencing on and from 4th September, 2017.
