IN exercise of the powers conferred upon the Minister by section 3 of the Constitutional Offices (Terms and Conditions of Service) Act, the Minister hereby makes the following regulations -

2. Regulation 2 of the Constitutional Offices (Terms and Conditions of Service) (Governor-General) Regulations (hereinafter referred to as the "principal Regulations") is hereby amended by deleting paragraph (1) and substituting therefor the following -
- (1) The Governor-General shall be paid a fortnightly salary of \$5,000.00.

3. Regulation 9(1) of the principal Regulation is hereby amended by deleting the words "forty dollars" and substituting therefor the words "three hundred dollars".

4. Regulation 10(1) of the principal Regulation is hereby deleted and the following new regulation substituted therefor

- (1) Subject to the provisions of paragraph (2) the Governor - General shall be entitled on official overseas travel to an allowance of US\$300.00 per day.
5. Regulation 12(1) of the principal Regulation is hereby amended by deleting the words "six thousand" and substituting therefor the words "ten thousand".
