1. This Ordinance shall be entitled the Guadalcanal Province Appropriation Ordinance 1996 and shall come into force upon approval of the Minister in accordance with Section 32 of the Provincial Government Act 1981 and publication in the Solomon Islands Gazette.

2. The appropriation from the Provincial Fund is hereby authorised of a sum of Five Million Nine Hundred and Seventy Eight Thousand Six Hundred and Fifty Five Dollars to be applied for the purpose specified in Section 36(2) of the Provincial Government Act 1981, and to the Service of the Financial Year ending 31st March, 1997.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of Heads and Subheads specified, and in the amounts respectively specified in relation thereto, in the Schedule to this Ordinance.
