NOTICE TO HOLD PROVINCIAL ELECTIONS 2006

IN exercise of the powers conferred by sections 9 and 10 of the Provincial Government Act 1997 as read with Regulation 9 of the Provincial Assemblies Election Regulation 1987, I, **JAPHET WAIPORA**, Minister of Provincial Government and Rural Development hereby:-

- (i) Appoint the **5th Day of December 2006** as the date for holding of the Provincial Assembly Election for **Central Islands Province**;
- (ii) Appoint **Mr. Michael Salini** to be the **Returning Officer** for the Central Provincial Assembly Election; and
- (iii) Require that nominations in respect of candidates for the Election be delivered to the Returning Officer at the **Provincial Headquarter, Tulagi**, not later than **4 0'clock** in the afternoon of **Tuesday the 7th Day of November, 2006**.
