(No. 14 of 1988)

THE PUBLIC SERVICE (OVERSEAS SERVICE) (AMENDMENT)  
REGULATION 1998

IN exercise of the powers conferred by section 4 of the Public Service Act, 1988. I. BARTHOLOMEW ULUFA'ALU, Prime Minister and Minister for Public service, do hereby make the following Regulations -

1. This Regulation may be cited as the Public Service (Overseas Service) (Amendment) Regulation 1998. Citation.

2. The Public Service (Overseas Service) of new Regulations 1993\* is hereby amended by deleting the Schedule and substituting therefor a new Schedule - Insertion.
