IN exercise of the powers conferred by section 16 of the Consumer Protection Act, (Cap. 63), the Minister hereby makes the following Order -

1. This Order may be cited as the "SOY SAUCE PRODUCTS" Recall Order 2001.
2. All wholesalers and Retailers of the following "SOY SAUCE PRODUCTS"-

are hereby;

- (a) prohibited to sell to the public the above named products until further notice;
- (b) ordered to disclose to the public through the media that the above named soy sauce products are not safe for human consumption and should be set aside from selves;

- (c) ordered to recall all "SOY SAUCE PRODUCTS" which are distributed to all its customers and which ever persons have the above named products in their possession, custody, control;
- (d) orderedd dto recall the above-namedd products before the fourteenth day of September 2001.
- (e) ordered to do any other actions which it deems appropriate to facilitate the aforesaid orders and the purpose and intention of this whole Order.
