NOTICE TO HOLD PROVINCIAL ASSEMBLY BYE-ELECTIONS IN JUNE 2011

IN exercise of the powers conferred by section 9 and 10 of the Provincial Government Act 1997, as read with Regulation 9 of the Provincial Government Election Regulations 2010, I, Hon. Walter Folotalu, Minister for Provincial Government and Institutional Strengthening hereby:-

- (i) Appoint the 22nd day of June 2011 as the date for holding of the Provincial Assembly Bye-Election in Ward 3 of Isabel Province;
- (ii) Appoint Mr. John M. Lokumana to be the Returning Officer for the Isabel Provincial Assembly Bye-Election;
- (iii) Require that nominations in respect of candidates for the Bye-Election be delivered to the Returning Officer at the Provincial Headquarter, Buala Station not later than 4 o'clock in the afternoon of Wednesday the 25th day of May 2011.
