**AUTHORISATION FOR A MINISTER TO PERFORM THE FUNCTIONS

IN exercise of the powers conferred by section 38(1) of the Constitution and acting in accordance with the advice of the Prime Minister, I, **SIR FRANK UTU OFAGIORO KABUI**, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Cross of the Order of Solomon Islands, Officer of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of Solomon Islands, do hereby authorize the person for the time being holding the office of—

**MINISTER OF FINANCE AND TREASURY**

to perform the functions conferred upon the Prime Minister by the Constitution of Solomon Islands from the date hereof until the return of the Deputy Prime Minister to Solomon Islands.
