**THE MAGISTRATES' COURT ACT  
(CAP. 20)**

**THE MAGISTRATES' COURT (INCREASE OF JURISDICTION)  
(NO. 1 ORDER 2013)**

**IN EXERCISE** of the powers conferred on me by section 27(23) of the Magistrates' Courts Act, I Sir Albert Rocky Palmer CBE, Chief Justice of the High Court of Solomon Islands hereby make the following order:-

1. This order may be cited as the Magistrates' Court (increase in criminal jurisdiction) (No. 1) Order 2013
2. Leonard R. Maina is hereby invested with jurisdiction to try the following case in the Magistrates' Court:

Regina – V – Pimbo Ogatuti:

**Count 1**

**Statement of Offence**

Defilement of a girl under 13 years of age contrary section 142 (1) of Penal Code

**Particulars of Offences**

That Pimbo Ogatuti of Gizo Pharmacy, Gizo at Gizo Pharmacy in the Western Province on unknown date between 31st September 2005 and 1st November 2005 did have unlawful sexual intercourse with a girl namely Miss Mayzy Jack under the age of thirteen years to wit 9 years 10 months old.

**Count 2**

**Statement of Offence**

Defilement of a girl under 13 years of age contrary section 142(1) of Penal Code

**Particulars of Offences**

That Pimbo Ogatuti of Gizo Pharmacy, Gizo at Gizo Pharmacy in the Western Province on unknown date between 30th September 2005 and 1st January 2006, did have unlawful sexual intercourse with a girl namely Miss Mayzy Jack under the age of thirteen years to wit 10 years old.

Defilement of a girl under 13 years of age contrary section 142(1) of Penal Code

**Particulars of Offences**

That Pimbo Ogatuti of Gizo Pharmacy, Gizo at Gizo Pharmacy in the Western Province on 17th July 2006, did have unlawful sexual intercourse with a girl namely Miss Necilyn Kerry Homelo under the age of thirteen years to wit 11 years 6 months.

**Count 4**

Defilement of a girl under 13 years of age contrary section 142(1) of Penal Code

**Particulars of Offences**
