**The Honiara City Council Appropriation Ordinance 2018**

**AN ORDINANCE**

**TO**

Appropriate FIFTY MILLION AND ONE HUNDRED TWENTY FOUR THOUSAND, ONE HUNDRED AND TWENTY SIX Dollars to the services of the financial year ending 31<sup>st</sup> December 2018.

Enacted by the Honiara City Council with the Assent of the Minister as follows:

1. This Ordinance may be cited as the Honiara City Council Appropriation Ordinance 2018 and shall come into effect on the date it is assented to by the Minister of Home Affairs in accordance with section 35(2) of the Honiara City Act 1999.
2. The issue of the sum of FIFTY MILLION AND ONE HUNDRED TWENTY FOUR THOUSAND, ONE HUNDRED AND TWENTY SIX Dollars (\$50,124,126.00) to the services of the financial year ending 31<sup>st</sup> December 2018.
3. The Sum specified in the preceding section shall be appropriation for the supply of Heads and Subheads specified in the schedules and in the amounts respectively in relation thereto.
