1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 17) Order 2017, and commences on 1 July 2017.
2. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by deleting serial no. 13 (Petroleum Products) and substituting the following:

**CUSTOMS AND EXCISE (IMPORT DUTY) (AMENDMENT)
ORDER 2017**

I, **Hon. Snyder Rini**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

Citation

1. This Order may be cited as Customs and Excise (Import Duty) (Amendment) Order 2017.

Commencement

2. This Order commences on 1 August 2017.

Amendments to the First Schedule of the Act

3. The First Schedule to the *Customs and Excise Act* (Cap. 121), entitled "IMPORT CLASSIFICATION AND TARIFF" is amended in the following respects:
 - (a) in respect of tariff item "2401.1000", by deleting the duty rate of "21.78%" per kg and substituting "25.05%" per kg;
 - (b) in respect of tariff item "2402.1000", by deleting the duty rate of "\$762.736" per kg and substituting "\$877.15" per kg;
 - (c) in respect of tariff items "2402.2010", "2402.2020", and "2402.9000", by deleting the duty rates of "\$1.888" per stick and substituting "\$2.171" per stick;
 - (d) in respect of tariff item "2403.1100": by deleting the duty rate of "\$618.695" per kg and substituting "\$711.499" per kg;
 - (e) in respect of tariff items "2403.1900", "2403.9100", "2403.9900", by deleting the duty rates of "\$1006.819" per kg and substituting "\$1157.842" per kg.

**CUSTOMS AND EXCISE (EXCISE DUTIES) (AMENDMENT)
ORDER 2017**

I, **Hon Snyder Rini**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121) make the following Order.

Citation

1. This Order may be cited as Customs and Excise (Excise Duties) (Amendment) Order 2017.

Commencement

2. This Order commences on 1 August 2017.

Amendment to the First Schedule of the Act

3. The First Schedule to the *Customs and Excise Act* (Cap. 121) entitled EXCISE CLASSIFICATION AND TARIFF is hereby amended in the following respects:
 - (a) by deleting the duty rate of "\$80.59" per kg which appears in respect of tariff E.1 (a) and substituting the duty rate "\$92.68" per kg;
 - (b) by deleting the duty rate of "\$0.3484" per stick which appears in respect of tariff item E.1 (b) and substituting the duty rate "\$0.4007" per stick;
 - (c) by deleting the duty rate of "\$675.47" per kg which appears in respect of tariff item E.1 (c) and substituting the duty rate "\$776.79" per kg.
