EMERGENCY POWERS (COVID-19) (NO. 4) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 45) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19) (No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1. Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 45) Order 2020*.

2. Commencement

This Order commences on the day it is published in the Gazette.
