**EMERGENCY POWERS ACT

**EMERGENCY POWERS (COVID-19)(No. 3) REGULATIONS 2020**

**EMERGENCY POWERS (COVID-19)(EXTENSION OF  
QUARANTINE)(NO. 2) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, the Prime Minister, under regulation 22A of *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Extension of Quarantine)(No. 2) Order 2020*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Definition**

In this Order:

“*extended quarantine period*” means the period for which a quarantine period is extended under paragraph 4(2) or (3).

**4 Extension of quarantine**

- (1) The quarantine period of the persons who entered Solomon Islands on 29 September 2020 is extended as specified in this paragraph.
- (2) The quarantine period of each person specified in Schedule 1 is extended for 21 days ending on 3 November 2020.
- (3) The quarantine period of each person specified in Schedule 2 is extended for 7 days ending on 27 October 2020.

**5 Testing of persons whose quarantine extended under paragraph 4(2)**

- (1) Each person whose quarantine period is extended under paragraph 4(2) must be tested for the presence of COVID-19:
  - (a) on the second day of the extended quarantine period; and
  - (b) on a day between the fifth day and the tenth day of the extended quarantine period; and
  - (c) on a day between the twelfth day and the fourteenth day of the extended quarantine period; and
  - (d) on a day between the nineteenth day and twenty-first day of the extended period.
- (2) Each of those persons must test negative for COVID-19 for each of the 4 tests.

**6 Testing of persons whose quarantine extended under paragraph 4(3)**

- (1) Each person whose quarantine is extended under paragraph 4(3) must be tested for the presence of COVID-19 on the fifth day of the extended quarantine period.
- (2) Each of those persons must test negative for COVID-19 for the test.

**7 Revocation**

The *Emergency Powers (COVID-19) (Extension of Quarantine) Order 2020* (Legal Notice 165 of 2020) is revoked.
