LAND AND TITLES ACT

(Cap. 133)

LAND AND TITLES (GENERAL) (AMENDMENT) REGULATIONS 2025

I, Hon. Polycarp Paea, Minister for Lands, Housing and Survey, under section 260 of the *Land and Titles Act* (Cap. 133), make the following Regulations:

1 Citation

These Regulations may be cited as the *Land and Titles (General) (Amendment) Regulations 2025*.

2 Commencement

These Regulations commence on the date these Regulations are published in the *Gazette*.

3 Amendment of Land and Titles (General) Regulations

These Regulations amend the *Land and Titles (General) Regulations* (Legal Notice No. 164 of 1993) ("*Principal Regulations*").

4 Regulation 6(1) repealed and replaced

Regulation 6(1) of the Principal Regulations is repealed and replaced with the following:

"(1) The following fees are payable:
