FISHERIES MANAGEMENT ACT 2015

REVOCATION OF PROHIBITED ACTIVITIES (FISHING OR POSSESSION OF BECHE-DE-MER) ORDER 2025

I, Edward Honiwala, Director of Fisheries, under section 22(2) of the *Fisheries Management Act 2015* (No. 2 of 2015) and with reference to section 36(a) of the *Interpretation and General Provisions Act* (Cap. 85), revoke the Order prohibiting fishing or possession of beche-de-mer (published as Legal Notice No. 226 of 2021), with effect on and from 22 April 2025.

IMMIGRATION ACT 2012

REDUCTION OF RESTRICTION PERIOD
