**COCONUT AND COCONUT PRODUCT MANAGEMENT FEES
REGULATIONS 2026**

I, Hon. Harry Degruit Kuma, Minister for Commerce, Industry, Labour and Immigration under section 34 of the *Commodities Export Marketing Authority Act* (Cap. 36), and on the recommendation of the Authority for the purpose of section 8(g) of the Act, make the following Regulations:

- 1 Citation**
These Regulations may be cited as the *Coconut and coconut product management fees Regulations 2026*.
- 2 Commencement**
These Regulations commence on the date of publication in the *Gazette*.
- 3 Rate of coconut product export management fee**
The rate of management fee for exporting coconut product is as follows:
 - (a) \$3,051.00 per tonne of copra export;
 - (b) \$6,082.00 per tonne of coconut oil export.

THE COCOA (AMENDMENT) REGULATIONS 2026

I, Hon. Harry Degruit Kuma, Minister for Commerce, Industry, Labour and Immigration under section 34 of the *Commodities Export Marketing Authority Act* (Cap. 36), and on the recommendation of the Authority, make the following Regulations:

1 Citation

These Regulations may be cited as *The Cocoa (Amendment) Regulations 2026*.

2 Commencement

These Regulations commence on the date of publication in the *Gazette*.

3 Amendment of the Cocoa Regulations 1986

These Regulations amends *The Cocoa Regulations* (LN 98 of 1986) (“*Principal Regulations*”).

4 Regulation 1 8(1)(a) amended

The *Principal Regulations* is amended in regulation 18(1)(a) by substituting “\$60.00 per tonne” with “\$2,992.00 per tonne”.

5 Regulation 1 8(1)(c) amended

The *Principal Regulations* is amended in regulation 18(1)(c) by substituting “\$60.00 per tonne” with “\$2,992.00 per tonne”.
