AN ACT
TO APPROPRIATE MONEYS TO THE SERVICE
OF THE GOVERNMENT

[20th November, 1995.]

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1. This Act may be cited as the 1995-96 Appropriation Act, 1995 and shall be deemed to have come into operation on the first day of July 1995 Act, (No. 4) 1995.

2. There shall be issued from general revenue and other funds of the Kingdom and applied to the service of the year ending the thirtieth day of June, One Thousand Nine Hundred and Ninety-Six any sum or sums not exceeding the sum of Three hundred and Forty-Five thousand pa'anga for defraying the charge of the Government of Tonga for such period in the manner expressed in the Schedule to this Act.

3. The Treasurer shall issue and pay such sum or sums of money for the purposes set out in the Schedule not exceeding in the whole the sums respectively in that behalf as the Prime Minister shall by warrant under his hand direct.

4. The moneys granted by this Act are intended for the services in respect of which moneys will become payable within the financial year ending on 30 June, 1996 and any balance thereof unissued at the end of the month of June 1996 shall lapse and not be available for making payment in any subsequent month.

'Oku fakahangahanga 'a e ngaahi pa'anga 'oku fakangofua 'e he Lao' ni ki he ngaahi ngäue pea 'e totongi atu 'a e ngaahi pa'anga ko ia lolotonga 'o e ta'u fakapa'anga 'o ngata 'i he 'aho 30 'o Sune 1996 pea ka 'i ai ha toe 'o e pa'anga ko ia 'o 'ikai ke fakahau kimu'a 'i he 'osi 'a e mahina ko Sune 1996 kuo pau 'e 'ikai ngäue'aki mo ngofua ke fai 'aki ha totongi 'i he mshina kirivu mei.
