CIVIL AVIATION ACT 1990

(Section 7)

CIVIL AVIATION (AMENDMENT) REGULATIONS 1996

In exercise of the powers conferred on him by section 7 of the Civil Aviation Act 1990, the Minister of Civil Aviation, with the consent of Cabinet, makes the following Regulations:

1. (1) These Regulations may be cited as the Civil Aviation (Amendment) Regulations 1996, and shall be read together with and deemed part of the Civil Aviation Regulations 1992 (hereinafter referred to as the principal regulations).
 - (2) These Regulations shall come into force on the 14th day after the date of their publication in the Gazette.
2. The principal regulations are hereby amended by inserting after regulation 1 the following:

Promulgation of Orders and Notices

1. A. (1) Notwithstanding any provisions of these Regulations to the contrary, wherever in these Regulations the Minister is empowered or required to issue any order, requirement or instruction, or to prescribe any procedure or condition, or to exercise any act or authority having a like or general effect, the Minister shall publish a document containing the order, requirement, instruction, or other matter in such of the publications referred to in paragraph (4) of this regulation as he may determine as appropriate to the circumstances.
 - (2) The fact that any document referred to in paragraph (1) of this regulation has been so published shall be conclusive evidence of the matter contained therein having been promulgated for the purposes of these Regulations.
 - (3) Any order, requirement, instruction, or other matter contained in the publications referred to in paragraph (4) of this regulation or promulgated as provided for in paragraph (1) of this regulation shall be deemed to have been issued by the Minister pursuant to these Regulations and shall be complied with by all persons affected thereby.
 - (4) For the purposes of giving effect to these Regulations and for the amplification of content the Minister may from time to time issue the following:

Civil Aviation Notices (CAN) - relating to the registration of aircraft, maintenance, operation, flight or manoeuvre of aircraft, or the use of any aerodrome or navigational facility, or for the purpose of promulgating orders or procedures in respect of air traffic control

or in respect of requirements for persons holding or applying for licences, ratings, certificates, approvals, or other authorities under these Regulations."

3. Regulation 2 of the principal regulations is hereby amended by inserting the following definitions in alphabetical order:

" "approved" means approved in writing by the Minister".

" "foreign type certificate" is a document granting design approval to an aircraft, aircraft engine or propeller and identifying the applicable airworthiness design standards and aircraft operating limitations, issued by a foreign aviation authority responsible for regulating airworthiness standards of civil aircraft in that country".

4. Regulation 5 of the principal regulations is hereby amended by inserting, after regulation 5(6), the following:

"(7) An aircraft intended for operation in the transport, aerial work or private category shall not be eligible for Tongan registration unless there is in force at the time of application, a foreign type certificate relating to that particular aircraft, complying with airworthiness design standards as specified in Civil Aviation Notices".

5. Regulation 14 of the principal regulations is hereby amended by inserting after regulation 14(2)(b), the following:

"(c) there being in force at the time of application, a foreign type certificate for the aircraft in compliance with airworthiness design standards as specified in Civil Aviation Notices and if he so requires, the associated type data."

6. Regulation 94 of the principal regulations is hereby repealed and replaced by the following:

"94. (1) Subject to the provisions of these Regulations, no aircraft shall be flown over any city, town, settlement or populous area at a lower height than 1,000 ft; or any other area at a lower height than 500 ft.

(2) Notwithstanding paragraph (1) above, no aircraft shall be flown over any city, town, settlement or populous area except at such altitude as will enable the aircraft to complete a safe landing should engine failure or other cause necessitate a forced landing.

(3) The height specified in paragraph (1) hereof, is the height above the highest point of the terrain or any obstacle thereon, within a radius of one nautical mile.

(4) The provisions of paragraphs (1) and (2) of this regulation shall not apply if:

(a) through stress of weather encountered en route or any other unavoidable cause, it is essential that a lower altitude be maintained; or

- (b) the aircraft is engaged in an operation of a nature which necessitates low flying and approval has been given by the Minister either for all flights or for a specific flight or flights to be made at a lower altitude and the flight is in accordance with such conditions as the Minister may prescribe; or
 - (c) the aircraft is being flown in an area designated by the Minister for use as a low-flying area by the operator of an aircraft and the flight is in accordance with such conditions as the Minister may prescribe; or
 - (d) the aircraft is taking off or landing.
- (5) Notwithstanding the provisions of paragraphs (1) and (2) of this regulation an aircraft engaged in IFR flight shall comply with the provisions of Regulation 112".

CIVIL AVIATION ACT 1990

CIVIL AVIATION (AERODROMES AND LICENSING CHARGES) REGULATIONS 1996

In exercise of the powers conferred on him by section 7 of the Civil Aviation Act 1990, the Minister of Civil Aviation, with the consent of Cabinet, makes the following Regulations:

1. (1) These Regulations may be cited as the Civil Aviation (Aerodromes and Licensing Charges) Regulations 1996.
- (2) These Regulations shall come into force on the 14th day after the date of their publication in the Gazette.
2. The Civil Aviation (Aerodromes Charges) Regulations 1991 are hereby repealed.
3. The charges specified in the schedule hereto shall be paid by the operators of all aircraft except as provided in the said schedule.

SCHEDULE LANDING CHARGES

1. Subject to the provisions of paragraphs 2 and 3 of the schedule, Landing Charges in accordance with the following scale per one tonne (1,000 kg) weight shall be charged and payable in respect of each landing at an aerodrome by an aircraft engaged in the carriage of passengers, cargo or mail.

(a) Domestic Operations	- \$ 3.50 per tonne
(b) International Operations

B767 Series	- \$ 1,908.00
B737 Series	- \$ 687.00
All other aircraft types	- \$ 10.90 per tonne

International Airport	- \$ 8.00 per tonne

2. In calculating the landing charges in accordance with the per tonne scale set out in the preceding paragraph, the weight of the aircraft shall be the maximum permissible take-off weight of the aircraft as authorised by the Aircraft Flight Manual or other equivalent document, reckoned to the nearest 1,000 kg.
3. In the case of the landing of an aircraft with a maximum permissible take-off weight exceeding 5,000 kg whilst engaged on a flight made solely for the purpose of training aircrew personnel, the landing charges shall be 25% of the appropriate charge set out in paragraph 1 of the schedule.
4. The landing charges detailed in paragraph 1 of the schedule are inclusive of all terminal navigational aid charges.

5. The following aerodrome lighting surcharges are in addition to the above charges when flights operate between sunset and sunrise:

- (a) if a night landing is made between sunset and sunrise and the takeoff is made within one hour of that landing, a fixed charge of \$50.00 will be made;
- (b) if the duration of an aircraft on the ground after sunset and before sunrise exceeds the period specified in paragraph 5(a) of the schedule, each additional hour or part thereof shall be charged at \$35.00.

6. For the determination of applicability of aerodrome lighting charges, the actual times of sunset and sunrise referred to in paragraph 5 of the schedule, are as defined in the Twilight Tables contained in the appropriate Aeronautical Publication.

7. Payment of landing and where applicable lighting charges, shall be made in Tongan currency in the following manner:

- (a) every domestic operator shall forward within 30 days of the end of each month a return of the number of landings for that month together with payment for the landing charges thereon unless other arrangements have been approved by the Minister;
- (b) every scheduled international operator shall forward within 42 days of the end of each month a return on the number of landings for that month together with payment for the landing charges thereon unless other arrangements have been approved by the Minister;
- (c) every non-scheduled international operator shall pay his landing charges before take-off unless other arrangements have been previously approved by the Minister.

8. Charges will be reduced to one half for rotary wing aircraft.

9. The following aircraft shall be exempt from the payment of charges:

- (a) foreign military aircraft;
- (b) diplomatic aircraft;
- (c) State aircraft;
- (d) aircraft being used for Government ceremonial purposes;
- (e) search aircraft engaged in air/sea rescue operations;
- (f) aircraft engaged in disaster relief or emergency medical evacuation;
- (g) aircraft engaged in the calibration of the States navigational facilities;
- (h) aircraft carrying out a test flight solely for the purpose of establishing serviceability; and
- (i) aircraft that have received an exemption in writing from the Minister.

PARKING CHARGES

10. Subject to the provisions of paragraph 9 of this schedule charges shall be levied and payable for the parking of aircraft at any aerodrome for any period in excess of three hours and shall be paid in accordance with the following scale:

PERIOD AND RATES FOR PARKING

Aircraft Weight	Between 3 and 8 Hours	Each Additional Hour
Not Exceeding 5 tonnes	\$ 5.00	\$ 1.00
Between 6 and 50 tonnes	\$30.00	\$ 7.00
Exceeding 50 tonnes	\$60.00	\$12.00

11. For the purposes of paragraph 10 of this schedule the weight of an aircraft shall be assessed as the maximum permissible take-off weight as authorised by the Aircraft Flight Manual or other equivalent document reckoned to the nearest 1,000 kg.

12. Payments for parking charges shall be made in Tongan currency in the time-frame and manner as prescribed in paragraph 7 of this schedule.

13. Aircraft normally operational from and based at aerodromes within the Kingdom shall be exempted from the payment of parking charges.

CERTIFICATION OF AIRCRAFT AND LICENSING OF OPERATORS AND PERSONNEL

14. The fees payable for the issue of a Certificate of Registration in the first instance shall be \$250.00. Thereafter a fee of \$75.00 shall be payable for each registration transfer.

15. The fees payable for the issue of a Certificate of validation for a Foreign Certificate of Airworthiness shall be \$300.00.

16. The fee to be charged for the acceptance of every type Certificate of Airworthiness, Certificate of Type Approval or introduction onto the register of a first of type shall be at the discretion of the Minister and shall be based upon, but shall not exceed, the cost of the engineering investigation into the design and construction of the aircraft or aircraft components for the purposes of the certificate.

17. The fee for the issue of every series Certificate of Airworthiness shall be:

- (a) for aircraft with a maximum permissible take-off weight exceeding 5,700 kg \$650.00
- (b) for aircraft with a maximum permissible take-off weight exceeding 2,950 kg \$350.00

- (c) for an aircraft with a maximum permissible take-off weight below 2,950 kg - \$200.00
18. The fee for the renewal of every series Certificate of Airworthiness shall be:
- (a) for aircraft with a maximum permissible take-off weight exceeding 5,700 kg - \$350.00
 - (b) for aircraft with a maximum permissible take-off weight exceeding 2,950 kg - \$175.00
 - (c) for aircraft with a maximum permissible take-off weight below 2,950 kg - \$75.00
19. A fee of \$50.00 will be charged for the issue of a Validation Certificate to any licence, rating or approval and a fee of \$25.00 may be charged for any examination either written or oral that may be required for the purpose of the Validation Certificate issue.
20. A fee of \$750.00 shall be payable for the issue of a Maintenance Organisation Certificate of Approval.
21. A fee of \$1,000.00 shall be payable for the issue of an Air Operator Certificate.
22. A fee of \$150.00 shall be payable for the issue of an Aircraft Radio Station Approval.
23. A fee of \$25.00 shall be payable for the issue of a duplicate certificate or licence of any kind when the original is lost or destroyed. In the case of aircrew or engineering licences issued under the authority delegated to Aviation Services Limited of New Zealand, the replacement fee shall be as from time to time published by that organisation.
24. Until the appropriate fees and charges have been paid, the Minister may decline to do any act or permit any act to be done or to receive any document in respect of which the fees and charges are payable under these Regulations.

CIVIL AVIATION ACT 1990**CIVIL AVIATION (PASSENGER SERVICE CHARGE)
REGULATIONS 1996**

In exercise of the powers conferred on him by section 7 of the Civil Aviation Act 1990, the Minister of Civil Aviation, with the consent of the Cabinet, makes the following Regulations:

1. (1) These Regulations may be cited as the Civil Aviation (Passenger Service Charge) Regulations 1996.
(2) These Regulations shall come into force on the 14th day after the date of their publication in the Gazette.
2. The Civil Aviation (Passenger Service Charge) Regulations 1991 are hereby repealed.
3. Unless otherwise exempted under these Regulations any passenger 12 years of age or older embarking on an aircraft at an airport within Tonga for a destination outside Tonga shall pay to the Government a passenger service charge of \$20.00.
4. The manner in which the service charge shall be paid and collected and all forms and procedures appropriate thereto shall be determined by the Minister.
5. The following passengers shall be exempted from the payment of a passenger service charge:
 - (a) a Head of State;
 - (b) a Diplomat accredited to Tonga;
 - (c) transit passengers continuing their journey by the same or first connecting flight whether they leave the airport or not and up to a maximum period of 24 hours after arrival at the airport;
 - (d) children under 12 years of age;
 - (e) aircraft crews travelling on duty including positioning crews;
 - (f) passengers travelling in a State aircraft or an aircraft being used for the ceremonial purposes of Government;
 - (g) passengers and technicians travelling in an aircraft being used to calibrate the State's navigational facilities;
 - (h) passengers travelling on an aircraft engaged in disaster relief or emergency medical evacuation;
 - (i) passengers travelling on an aircraft engaged in air/sea rescue operations;
 - (j) military aircraft crews and personnel; and
 - (k) any passenger specifically exempted in writing by the Minister.

6. In any case where an aircraft lands at an airport within Tonga because of an emergency no passenger service charge will be payable in respect of the later departure of a passenger arriving on that aircraft whether the passenger leaves on the same aircraft or not or whether the passenger leaves the airport or not.
7. All passenger service charges collected in accordance with these Regulations shall be deemed Government revenue.
8. Any passenger who knowingly fails to pay the passenger service charge imposed by these Regulations shall be guilty of an offence and be liable on conviction to a fine not exceeding \$100.00 or to imprisonment for a period not exceeding one month or to both such fine and imprisonment.
9. The Minister may delegate his powers under these Regulations in the manner provided under section 5 of the Civil Aviation Act 1990.

CIVIL AVIATION ACT 1990

CIVIL AVIATION (RESTRICTION OF USE OF LAND) REGULATIONS 1996

In exercise of the powers conferred on him by section 14(1) of the Civil Aviation Act 1990, the Minister of Civil Aviation with the consent of Cabinet makes the following Regulations.

1. (1) These Regulations may be cited as the Civil Aviation (Restriction of Use of Land) Regulations 1996.
 (2) These Regulations shall come into force on the 14th day after the date of their publication in the Gazette.
2. The Civil Aviation (Restriction of Use of Land) Regulations 1991 are hereby repealed.
3. The following are prohibited and restricted in the areas specified in the First, Second and Third Schedules and the diagrams referred to therein:
 - (a) the erection of buildings, structures or other things;
 - (b) the planting of trees;
 - (c) the sowing or growing of any plant or crop except with the consent of the Minister in areas specified by the Minister in writing;
 - (d) the bringing of vessels, machinery or vehicles or the anchoring or mooring of any vessel or the parking of any machinery or vehicle.
4. Any person acting in contravention of these Regulations commits an offence and shall be liable on conviction to a fine not exceeding \$500 or to imprisonment for a term not exceeding 2 years or to both.

SCHEDULE 1
FUA'AMOTU AERODROME · CLEARANCE

Transitional Side Surface:

On both sides of the east-south-east - west - north - west airstrip so that a line starting from any point at ground level on the edge of the airstrip, 150 metres from the center line of the airstrip and drawn at right angles thereto and at a gradient of 1 in 7 from the horizontal will be clear of all obstructions.

On both sides of the north - south airstrip so that a line starting from any point at ground level on the edge of the airstrip, 45 metres from the center line of the airstrip, and drawn at right angles thereto at a gradient of 1 in 7 from the horizontal will be clear of all obstructions.




Approach/Take Off Surface:

On both sides or ends of the east - south - east - west - north - west airstrip there exist funnel shaped planes as shown in Diagram 1 on this schedule that will be clear of all obstructions. These planes are defined with a 150 metres long inner edge at right angles to the center lines of the airstrip located 300 metres horizontally in the direction of takeoff from the threshold of the airstrip and diverging on both sides at 12.5%. The planes incline at an angle of 1 in 62.5 (1.6%) to the horizontal from the inner edge, and have gradients at right angles to the center line of the airstrip of 1 in 7 from the edges of this plane.

On both ends of the north - south airstrip there exist funnel shaped planes as shown in Diagram 1 on this schedule that will be clear of all obstructions. These planes are defined with a 80 metres long inner horizontally in the direction of take-off from the threshold of the airstrip and diverging on both sides at 10%. The planes incline at an angle of 1 in 40 (2.5%) to the horizontal from the inner edge, and have the gradients at right angles to the center line of the airstrip of 1 in 7 from the edges of this plane.

Inner Horizontal Surface:

The horizontal surface is contained in a horizontal place located 150 feet (45 metres) above the aerodrome elevation datum. Its outer limits are at a horizontal radius of at least 4,000 metres measured from the periphery of the strip. Refer to Diagram 2.

SCHEDULE 2

KAUFANA, LAVINIA, MATA'AHO - AERODROME CLEARANCE

Transitional Side Surface:

On both sides of the north-south airstrip so that a line starting from any point at ground level on the edge of the strip, 30 metres from the center line of the airstrip and drawn at right angles thereto and at a gradient of 1 in 5 from the horizontal will be clear of all obstructions.


Approach/Take - Off Surface:

On both sides of the respective airstrips, there exist funnel shaped planes as shown in Diagram 1 of this schedule that will be clear of all obstructions. These planes are defined with a 80 metres long inner edge at right angles to the center line of the airstrip located 60 metres horizontally in the direction of take-off from the threshold of the airstrip and diverging on both sides at 10%. The planes incline at an angle of 1 in 20 (5%) to the horizontal from the inner edge, and have gradients at right angles to the center line of the airstrip of 1 in 5 from the edges of this plane.

Transitional Side Surface:


On both sides of the respective airstrips, so that a line starting from any point at ground level on the edge of the airstrip, 45 metres from the center line of the airstrip and drawn at right angles thereto and at a gradient of 1 in 7 from the horizontal for a distance of 45 metres above aerodrome datum, will be clear of all obstructions.

Approach/Take-Off Surface:

On the northern end of the airstrip there exist funnel shaped planes as shown in Diagram 1 on this schedule that will be clear of all obstructions. The plane is defined with a 90 metres long inner edge at right angles to the center line of the airstrip located 90 metres horizontally in the direction to take-off from the threshold of the airstrip and diverging on both sides at 12.5%. The planes incline at an angle of 1 in 40 (2.5%) to the horizontal from the inner edge, and have gradients at right angles to the center line of the airstrip of 1 in 7 from the edges of this plane.

1. (1) 'E ui 'a e Ngaahi Tu'utu'uni ni ko e Ngaahi Tu'utu'uni (Fakatonutonu) 'o e Fefolau'aki Vakapuna Sivile 1996, pea kuo pau ke lau ko e konga ia 'o e Ngaahi Tu'utu'uni 'a e Fefolau'aki Vakapuna Sivile 1992 ('a ia 'oku ui hen'i ko e ngaahi tefito'i tu'utu'uni).
- (2) Kuo pau ke kamata ngaue'aki 'a e Ngaahi Tu'utu'uni ni 'i he 'aho hono 14 mei he 'aho 'e pulusi ai 'i he Kasete.
2. 'Oku fakatonutonu hen'i 'a e ngaahi tefito'i tu'utu'uni 'aki hono fakahu atu 'eni 'i he ngata'anga 'o e tu'utu'uni I:

"tali" 'oku 'uhinga ia ki he tali 'e he Minisitā 'i he tohi."
