ORDER-IN-COUNCIL

LICENCES ACT

(Section 5(1) and (3))

In exercise of the powers conferred by section 5 of the Licences Act (Cap. 47), as amended, the Privy Council makes the following Order:

1. This Order may be cited as the Licences (Squash Export) Order 2002.
2. That the Hon. Minister of Labour, Commerce & Industries be appointed and approved to issue licences under the Licence Act.
3. The maximum number of licenses that may be issued under the Licences Act to export squash to Japan in 2002 shall be as follows:

'Eua	4
Vava'u	2
Stand-by for all districts	1
