## CONSUMPTION TAX ACT 2003

(Section 5(3)(a))

ORDER

**IN EXERCISE** of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister responsible for revenue services, with the approval of Cabinet, makes the following Order:

1. That the materials imported for the Foa Causeway Upgrade Project as certified by the Ministry of Finance and National Planning be exempted from consumption tax.
2. That the materials and supplies supplied for the Foa Causeway Upgrade Project as certified by the Ministry of Finance and National Planning shall be exempted from consumption tax.
