#### NOTICE OF BY-ELECTION

NOTICE IS HEREBY GIVEN that the By-Election for the District Officer of Hahake, Vava'u pursuant to Section 6 of the District and Town Officers Act (as amended) will be held on **Tuesday the 12th day of November in the year 2019.**

NOMINATIONS should be left with the Returning Officer at the Governor's Office in Vava'u no later than four in the afternoon on the **24<sup>th</sup> day of October in the year 2019**, or no later than **four in the afternoon on the immediately preceding day** subject always to the following provisions:-

1. Nominations shall be in writing and shall be subscribed with the signatures of at least 10 persons who are qualified electors namely electors who are resident in the District for which election is sought by the candidate and their names shall be inscribed in the latest electoral roll published in accordance with the Electoral Act.
2. The Returning Officer shall certify that persons subscribing as a candidate's proposers are eligible to do so.
3. The candidate shall be required, before his nomination is accepted, in addition to the above requirements, to pay a candidate registration fee in the sum of 50 Pa'anga.
