ORDER

IN EXERCISE of the powers conferred upon me by section 11(4) of the Magistrate's Court Act ("the Act"), I hereby extend the power of Senior Magistrate 'Elisapeti Langi to hear and determine criminal cases, and with the consent of the Prosecution and the Defendant, in accordance with sections 35 or 36 of the Act, to impose a maximum punishment not exceeding seven years imprisonment or a fine of \$50,000.

Subject to further Order, and unless renewal beforehand, this Order shall expire on 30 June 2025.
