Detainee Name: Leisong John

Decision: She was sentenced to 3 years 8 months for incest. She has undertaken Mind Education, Family Violence, Anger Management and victim Awareness Programs. She accepted responsibility. She was very adequately for her reintegration back into the Community. Her application is approved on standard and special conditions to remain until her Sentence End Date on 11/04/2021.

Release Condition: - To be supervised by Chief Albert Kalaumara

- To undertake Spiritual Counselling with Peter Tanearu (Senior Pastor of AOG, Saama Village)
- To perform a Custom Ceremony to her Chief and the community of Saama of painting a bad reputation to the community.
- To undertake "Niufala Rod Program" as directed by a Probation Officer.
- To undertake "Victim Awareness Program" as directed by the Probation Officer
- Not to re-offend

Detainee Name: Namataku Maepesa Kalsaria

Decision: He was sentenced to 1 year 4 months for money laundering offences. He has undertaken some rehabilitation programs not directly relevant to his offendings, however we are satisfied he is no long of any risk to the community. We therefore approve his application for release on parole on standard and special conditions.

Release Condition: -To reside only at Malapoa White wood area and no other place else.

- To be under the care and responsibility of Chief Jeffery Luru.
- To undertake Spiritual Counselling with Church Elder Ruben Sam as directed by a Probation Officer.
- To undertake "Niufala Rod Program" as directed by a Probation Officer.
- Not to re-offend.

Decision: She was sentenced to 2 years imprisonment for money laundering offences. We approve her for release on parole to remain until 05/04/2020.

Release Condition: -To be supervised by Chief Paul Fred as his CJS.

- To undertake "Niufala Rod Program" as directed by a Probation Officer.
- To undertake "Victim Awareness and Budgeting Program" as directed by the Probation Officer.
- To perform the custom reconciliation to the victim if identified in the future.
