- Undertake Spiritual counselling with Pastor Per Lop
- Undertake Rehab Programs as Sexual Offending and Victim awareness
- Avoid re-offending
- Not to make any contact whether direct or indirect with the victim without prio to the Probation officer.

- To attend other rehabilitation programs as directed by Probation Officer
- To find means to reimburse the outstanding amount in cash to the Vanuatu Youth Challenge, if the Board sees appropriate
- Not to re-offend
- To find employment by 1st March 2020 to comply with the Restitution Order of the Court and to present receipt of payments to the Parole Board.
