Tugeta parties I appear before long Kot taem ibin sitaon blong lukluk long matter ia.

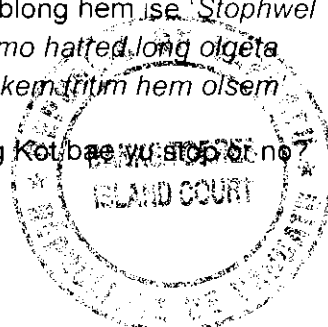
Long Kot complainant hemi talem se defendant istart blong killim hem since hemi yagfala kasem tedei.

Ol findings blong Kot.

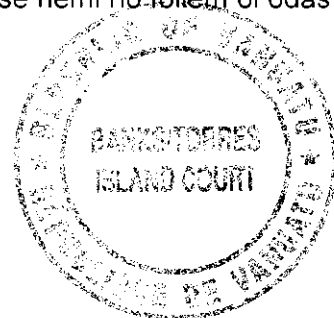
Hemia nao ol findings blong Kot.

Follem olgeta toktok ia, Kot istap mekem ol odas olsem:


Kot istap oda se:-

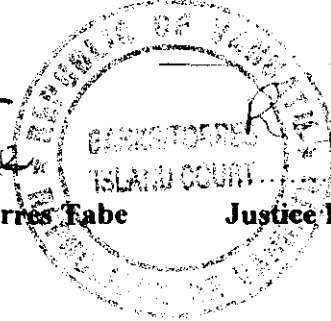


