Trifala case ia oli tokbaot ol custom properties we emi blong semak Late Momis Sakuliang so bae court i harem trifala case ia wantaim follem **Civil Procedure rules 49 of 2002 we long section 3.3 heading emi "Joining and separating claims" we long subsection (b) the claims arise out of the same transaction or event; or.** Section ia nao emi gem pawa long court ia blong harem trifala case ia wantaim.

Leiwia Morris emi filem tufala case blong em long yia 2022 and Jeaison emi filem case long yia 2024. Defendant emi jes filem response long 25 March 2024 bifo court i harem case ia.

Claim blong trifala case ia emi statm se Jeaison Sakuliang nao bae emi gat raet long ol properties blong late Morris Sakuliang mo Lerefiling.

Douglas Fatal emi spokesman on behalf blong Leiwia Morris we emi woman blong em mo adopted son blong Late Morris Sakuliang we emi Jeaison.



## CLAIM BLONG CLAIMANT

Morris Sakuliang mo olfala woman blong em Lerefiling tufala i gat wan gel nomo we emi Leiwia mo no gat any boe. Leiwia Morris emi only surviving daughter we em i maretem man ia nem blong em Douglas Fatal blong Lingarak vilij, Central Malekula. Tufala i gat 6 pikinnini we emi 3 gel mo 3 boe.

Statmen emi talem se ol properties blong late Morris we emi gat emi nasara Vinmari we i stap insaed long kastom boundary blong Gara. Taem gospel emi kam long yia 1950 late Momis Sakulaiang emi muv i kam daon long Hatbol vilij.

Long yia 1952 late Morris emi disaed blong pem tu pis blong graon long ol tribe blong Sachan mo Mindu blong emi sustainem living blong em mo families blong em. Ples we emi buildem haus blong em long em nem blong em emi Lomelvavi mo ples blong karen mo ples we oli plannem coconas nem blong em emi Vatugas.



Tufala pis graon we Morris emi pem emi pem cash and emi no wan kastom lan we emi mas mekem kastom blong kam liv long graon ia.

Leiwia Morris emi basem claim blong em se even ol properties blong papa blong em from we emi pass away finis bae em nao I gat raet long ol property ia. Emi talem tu se papa blong em I decide blong adoptem son blong em Jeaison blong I lukaotem ol properties blong papa blong em.

Samples araron long yia 1999 family Esrom oli destroyem ol wood long eria blong Vutugas mo oli trespass mo muv ko liv insaed long ol pis graon blong late Morris Sakulaiang we oli no askem long Leiwia we emi daughter blong Morris.

Late Morris mo Leref tufala I mekem wan kastom adopsen mo adoptem son blong gel blong tufala we nem blong em Jeaison. Long taem we Leiwia I gat bel Papa blong em Morris mo mama blong em Leref tufala I lukaotem gud em kasem we emi kasem hospital tufala I lukluk long hospital blong Leiwia mo pem ol klos blong Jeaison mo even tufala I tekem wan woman blong lukaot long Leiwia taem I stap long hospital, we tufala I talem tankio long woman ia wetem wan yam mo wan faol.

I gat wan Legal adopsen tu we Supreme court I grantem I ko long Late Morris Sakulaiang mo woman blong em blong blong letem blong tufala I adoptem Jeaison Sakulaiang olsem boe blong tufala blong owenem ol kastom properties blong Morris Sakulaiang.

Long risen se Jeaison emi son blong Leiwia we I maretem Douglas we emi blong wan difren nasara, so emi no gat raet blong tekem ol property blong late Morris from we Morris emi blong wan difren nasara.

Emi statem tu every chiefs blong olgeta oli no aware long adopsen ia mo se adopsen ia emi happen long wanem date. Emi statem tu se ol chiefs ia oli no receivem any pig blong adopsen ceremony ia.

Emi statem tu se Morris Sakulaiang emi no mekem any effort blong stanap bifo long ol chiefs blong Gara mo Longorka blong mekem adopsen blong Jeaison. Hem I pass away long 1999 and adopsen I jes tekem ples long yia 2000.

Jeaison emi no grow ap wetem late Morris Sakulaiang tu blong save gud long ol properties blong em moo I wokbaot blong em bifo emi save adopted.

Oli claim se adopsen I no gat wan chief blong Gara I sign wetem trifala witness ia, mo I no gat wan-chief blong Gara I stap bifo long Supreme court blong witnessem adopsen ia.



Oli statem tu se Late Morris mo woman blong em tufala I no aware long adopsen we I happen long Jeaison. Mo tufala I no luk ol kastom pefomens we oli pefomem blong mekem adopsen ia.



##### LONG DEFENDANT: -



4. Family Esrom I mas stop blong usem ol property blong late Morris Sakuliang olsem cocoa mo coconut
5. Sapos Family Esrom oli no respectem oda 1 kasem oda 4 bae Jeaison Sakuliang emi gat raet blong filem Enforcement I ko long wan Magistrate blong harem case ia.
6. Tugeta parties I gat 30 days blong apil agensem decision ia sapos oli no happy long decision.


