

NEW HEBRIDES CONDOMINIUM

JOINT REGULATION

No. 27 of 1975

TO AMEND the Customs Import Duties Joint Regulation No. 19 of 1963.

MADE by the Resident Commissioners under the provisions of Articles 2:2, 5 and 7 of the Anglo-French Protocol of 1914.

Amendments to Part 2 of Schedule to J.R. 19 of 1963

1. The Customs Import Duties Joint Regulation No. 19 of 1963 as from time to time amended (hereinafter called "the principal Regulation") is hereby further amended in Part 2 of the Schedule as follows: -

a) Classification 04X is deleted and replaced by the following new classification -

"04X: milk and cream, fresh, preserved, concentrated or sweetened; butter, cheese and curd, excluding honey (see 20X)

- (a) powdered milk 5%
- (b) other items15% .

(b) Classification 09X is deleted and replaced by the following new classification -

"09X: Coffee, tea, mate and spices such as pepper, pimento, vanilla, cinammon, thyme, saffron, cloves, nutmeg, mace, cardamons, bayleaves etc.

- (a) tea 5%
- (b) coffee 5%
- (c) other items15% .

(c) Classification 16.03 is deleted and replaced by the following new classification -

"16.03: preparations of meat, sausages, meat extract and juices (including classification 16.04)

- (a) canned beef products such as corned beef or corned meat25%
- (b) other items15% .

(d) Classification 16.05 is deleted and replaced by the following new classification -

"16.05: preparation of fish, crustaceans and molluscs (including Classification 16.04)

(e) Classification 19X is deleted and replaced by the following new classification -

"19X: preparations of cereals, flour or starches not otherwise classified, pastas, malt extract, puffed rice, cornflakes and similar products

(f) Classification 22.05 is deleted and replaced by the following new classification -

"22.05 Grape and must wine of less than 15° strength (includes 22.04)

- (g) Classification 22.06 is deleted and replaced by the following new classification -

"22.06: Vermonths and other flavoured grape wines of less than 25° strength	Litre	50 FNH plus 10% ad valorem on CIF price" .

- (h) Classification 22.09 is deleted and replaced by the following new classification -

"22.09: Spirits, liqueurs, absinthe,
anis-based spirits and other
spirituous beverages:-

(a) under 25° strength	Litre	150 FNH
(b) 25° to 37° strength	Litre	200 FNH
(c) 38° and over strength	Litre	300 FNH " .

- (i) Classification 37X is deleted and replaced by the following new classification -

"37X (a) Unexposed film and photographic plates		free
(b) Unexposed photographic papers and chemical products for photo- graphic use		20%
(c) Exposed film, plates and photographic paper		free

- (j) Classification 90.10 is deleted and replaced by the following new classification -

"90.10 Camera and photographic apparatus, projectors and parts and accessories for such apparatus		free

- (k) Classification 92X is deleted and replaced by the following new classification -

"92X Musical instruments, apparatus for recording and reproducing sound; parts and accessories for such instruments and pianos, stringed instruments, accordions etc. gramophones, dictating machines, tape recorders, parts and accessories for such machines -

- (a) apparatus for recording and reproducing sound, gramophones, dictating machines, tape recorders and parts and accessories for such machines free
- (b) other items 20% "

Alteration of certain tariffs in Part 2 of Schedule to J.R. 19 of 1963

2. The tariffs specified in the fourth column of Part 2 of the Schedule to the principal Regulation opposite each of the classifications listed in the left hand column below shall be deleted and replaced by the new tariffs hereunder respectively appearing opposite them -
