

NEW HEBRIDES CONDOMINIUMJOINT REGULATION

No. 43 of 1975

TO DECLARE the 10th day of November 1975 a public holiday.

MADE by the Resident Commissioners under the provisions of Articles 2:2 and 7 of the Anglo-French Protocol of 1914.

Declaration  
of public  
holiday

1. Notwithstanding the provisions of section 2 of the Joint Elections (Closing of Premises) Regulation No. 23 of 1975, the 10th day of November, 1975, shall be within the limits of the urban constituencies of Vila and Santo a public holiday.

Closing of  
premises to  
public

2. Subject to section 5, it shall be unlawful for any shop, office or commercial or industrial undertaking to remain open for public business on the said 10th day of November 1975.

Application  
to adjourned  
polling date

3. The provisions of section 1 and 2 shall apply to any other day to which polling for the election of representatives of the people in the Representative Assembly in the said urban constituencies or either of them may be adjourned under the provisions of section 21 of the Representative Assembly (Elections) Regulation No. 30 of 1975 as amended.

Offences

4. (1) Any person contravening the provisions of section 2 shall be guilty of an offence punishable upon conviction by a fine not exceeding 60,000 FNE or the equivalent thereof in Australian dollars at the official rate of exchange.

(2) For the purposes of subsection (1), every director, manager, partner or owner of any undertaking opened for public business in contravention of section 2 shall be deemed to be guilty of an offence unless he shows to the satisfaction of the Court that he did not wilfully or negligently authorise or permit such opening of the premises.

Exemptions

5. (1) The foregoing provisions of this Regulation shall not apply with respect to hotels, restaurants, public transport services, stevedoring companies, industrial electricity suppliers or any undertaking or class of undertaking specified by the Resident Commissioners for the maintenance of essential services.

(2) Any shop or other premises may be opened on the said 10th day of November for the sale of foodstuffs, pharmaceutical or medical supplies and petrol or fuel oil from 7.30 a.m. to 10.30 a.m.
