JOINT REGULATION

Nº 16 of 1979

TO PUT INTO EFFECT the Resolution of the Representative Assembly Nº 12 of 1979, passed the 15th day of May 1979, to amend the Representative Assembly (Delegation of Powers) Regulation 1979.

MADE by the Resident Commissioners under the provisions of Article 2 (2) of the Anglo-French Protocol of 1914 and Article 28 (3) of the Schedule to the Exchange of Notes made at London the 15th day of September 1977 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic.

1. The Resolution of the Representative Assembly Nº12 of 1979, set forth in the Schedule is hereby put into effect.

2. This joint Regulation may be cited as the Representative Assembly (Delegation of Powers) (Amendnt) Regulation 1979 and shall have effect from the date of its publication in the New Hebrides Gazette.

JOINT REGULATION

N°16 of 1979 : Schedule

REPRESENTATIVE ASSEMBLY RESOLUTION N° 12 OF 1979

to complete the provisions of Resolution N°22 of 1978 relating to the powers of the General Committee when the Representative Assembly is in recess.

THE REPRESENTATIVE ASSEMBLY OF THE NEW HEBRIDES at its sittings on 15th May 1979 hereby resolves and decides, in accordance with the Schedule to the Exchange of Notes, the Standing Orders of the Representative Assembly, and Resolution N°22 of 1978 to provide for the delegation of powers to the General Committee when the Representative Assembly is in recess to adopt the following measures :

SECTION 1 The provisions of Section 1 of Resolution N°22 of 1978 are hereby revoked and replaced by the following provisions :

When the New Hebrides Representative Assembly is in recess it delegates to the General Committee the power to make decisions on draft legislation submitted to it by the Government or by the Special or Ad Hoc Committee for the purpose of :

- a) effecting a revision of the New Hebrides Budget;
- b) approving the Articles of Companies of general concern to the New Hebrides and the possible participation of the Government in such companies;
- c) approving the Regulations of public New Hebridean authorities and bodies;
- d) establishing funds or statutory bodies arising out of the necessity to create separate accounting procedures for any financial undertakings of the Government and approving the rules relating to the organization and operation of such funds or statutory bodies;
- e) authorizing the Government to raise loans, to request advances from the Treasury, to grant loans or make advances;
- f) authorizing the Government to acquire, alienate or exchange real property;
- g) organizing the public services of the Government;
- h) amending the New Hebrides Labour legislation;
- i) instituting a retirement and insurance scheme for Government employees and wage-earners in the private sector.
