CHAPTER 168

OFFICIAL SALARIES ORDER NO. 5 OF 1996

To amend the Schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred upon me by section 3 of the Official Salaries Act [CAP. 168], I, MAXIME CARLOT KORMAN, Prime Minister and Minister of Public Service, Planning and Statistics and Language Services, with the prior approval of the Council of Ministers, hereby make the following Order:-

AMENDMENT OF PART 1 OF THE SCHEDULE TO CHAPTER 168

- (b) (i) by adding after the item "Adviser to the Minister" the item "Filing Clerk";
- (ii) in column 2 after the item "1.684.584" corresponding to the item "Adviser to the Minister" the item "590.712" corresponding to the item "Filing Clerk";
- (iii) in column 3 after the item "B+D+E+G+F(iv)+I+J" corresponding to the item "Adviser to the Minister" the item "D+E+J" corresponding to "Filing Clerk";
- (c) (i) by adding after the item "Filing Clerk" the item "Messenger";
- (ii) in column 2 after the item "590.712" corresponding to "Filing Clerk" the item "360.000" corresponding to "Messenger";

- (iii) in column 3 after the item "D+E+J" corresponding to "Filing Clerk" the item "D+E+J" corresponding to "Messenger";
- (d) (i) by adding after the item "Messenger" the item "Office Gardener";
(ii) in column 2 after the item "360.000" corresponding to "Messenger" the item "288.000" corresponding to "Office Gardener";
(iii) in column 3 after the item "D+E+J" corresponding to "Messenger" the item "D+E+J" corresponding to "Office Gardener";
- (e) (i) by adding after the item "Office Gardener" the item "Ministers Residence Cleaner";
(ii) in column 2 after the item "288.000" corresponding to the "Office Gardener" the item "387.240" corresponding to "Ministers Residence Cleaner";
(iii) in column 3 after the item "D+E+J" corresponding to the "Office Gardener" the item "D+E+J" corresponding to "Ministers Residence Cleaner";
- (f) (i) by adding after the item "Ministers Residence Cleaner" the item "Receptionist";
(ii) in column 2 after the item "387.240" corresponding to "Ministers Residence Cleaner" the item "360.000" corresponding to "Receptionist";
(iii) in column 3 after the item "D+E+J" corresponding to "Ministers Residence Cleaner" the item "D+E+J" corresponding to "Receptionist".
