## Order No 49 of 1981

To provide for the sale of unclaimed property by public auction.

IN EXERCISE of the power contained in Section 77 (g) of the Police Regulation No 7 of 1980, I hereby make the following Order:

- 1. Any unclaimed property which the Police rould and Republic of Vanuatu has had possession of for a period of not less than three months may be disposed of by public auction.
- 2. The proceeds of such sale shall be paid into the General Revenue Fund of the Government of the Republic of Vanuatu.
- 3. This Order shall come into force on the date of signature.
