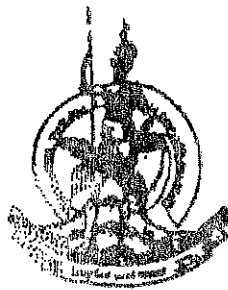

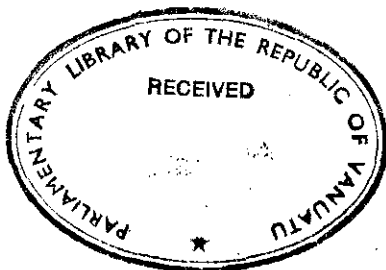

PRICE CONTROL (AMENDMENT) ORDER No. 6 OF 1988

To amend the Price Control Order No.30 of 1987.

IN EXERCISE of the power conferred by section 15 of the Joint Price Control Regulation No.18 of 1974, I hereby make the following Order:-

AMENDMENT OF ORDER No.30 OF 1987

1. The Price Control Order No.30 of 1987 is amended -

- (a) by the repeal of paragraph 1 and the substitution therefor of the following paragraph:

"MAXIMUM WHOLESALE AND RETAIL PRICES IN RESPECT OF TINNED MACKEREL, RICE, SARDINES AND SUGAR

1. The maximum wholesale and retail prices of tinned mackerel, rice, sardines and sugar set out under Column 1 in Part 1 shall be at the rates specified against such food stuff under Columns 2, 3, 4 and 5 in Part 1 of the Schedule;

- (b) by the repeal of the Schedule and the substitution therefor of the following Schedule:

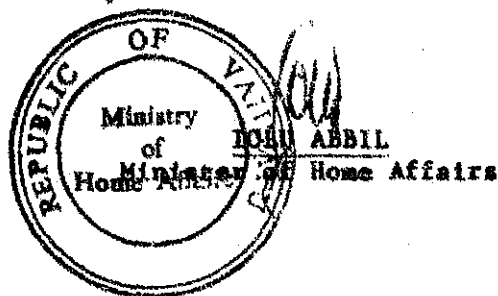


ORDER REVOKING BANKING LICENCE
