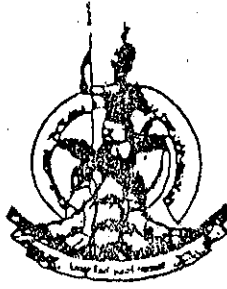

PRICE CONTROL (AMENDMENT) ORDER No. 26 OF 1988

To amend the Price Control Order No.30 of 1987.

IN EXERCISE of the powers conferred by section 15 of the Joint Price Control Regulation No.18 of 1974, I hereby make the following Order:-

AMENDMENT OF ORDER No.30 OF 1987

1. The Price Control Order No.30 of 1987 is further amended by the repeal of the Schedule and the substitution therefor of the following Schedule:
