AIRPORT (INTERNATIONAL) (METHOD OF COLLECTION) DEPARTURE TAX ORDER No.380F 1989

To provide for a method of collection of departure tax in respect of international airtravellers departing from Bauerfield, Pekoa Airport or Burton-Lenakel.

IN EXERCISE of the powers contained in section 3(3) of the Joint Airport Departure Tax Regulation No. 57 of 1973 as amended from time to time, 1 hereby make the following Order -

EXECUTING AUTHORITY

- (a) The Executing Authority of this Order shall in the first instance be the person for the time being appointed as the Director of Civil Aviation.
 - (b) Executing Authority shall procure all acts, obligations or responsibilities necessary to be performed to ensure the effective functioning of this Order.

ISSUING OF STAMPS

2. Stamps shall be issued to such hotels, banks, post offices, or retail stores and such other outlets or venues as may be appropriate for sale to intending travellers.

COLLECTION OF PROCEEDS

- All proceeds from the sale of stamps shall be collected from the vendors at the end of each month.
 - (b) Any proceeds unpaid shall be deemed a debt by the vendor and may be recovered by civil proceedings.

COMMENCEMENT

This Order shall come into force on the date of its publication in the Gazette.
