CHAPTER 168

THE OFFICIAL SALARIES (SITTING ALLOWANCES)  
ORDER No. 29 OF 1991

An Order to provide for sitting allowances for certain Office holders in the Schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred by section 3 of the Official Salaries Act [CAP. 168], as amended, I, DONALD KALPOKAS, Prime Minister and Minister of Justice and Public Service with the prior approval of the Council of Ministers, hereby make the following Order:-

**AMENDMENT OF PART I OF THE SCHEDULE TO CHAPTER 168**

1. Part I of the Schedule to the Official Salaries Act [CAP. 168] as amended, is further amended -
  - (a) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "5,000 per day or part of a day" corresponding to the Office of the "Chairman, Electoral Commission" in column 1 and substituting the item "4,000 per sitting";
  - (b) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "5,000 per day" corresponding to the Office of the "Chairman, Judicial Service Commission" in column 1 and substituting the item "4,000 per sitting";
  - (c) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "4,000 per day" corresponding to the Office of the "Member, Public Service Commission" in column 1 and substituting the item "3,000 per sitting";

- (i) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "5,000 per day" corresponding to the Office of the "Chairman, Teaching Service Commission" in column 1 and substituting the item "4,000 per sitting";
- (j) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "4,000 per day" corresponding to the Office of the "Member, Teaching Service Commission" in column 1 and substituting the item "3,000 per sitting";
- (k) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "5,000 per day" corresponding to the Office of the "Chairman, Health Practitioners Board" in column 1 and substituting the item "4,000 per sitting";
- (l) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "4,000 per day" corresponding to the Office of the "Member, Health Practitioners Board" in column 1 and substituting the item "3,000 per sitting";
- (m) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "5,000 per day" corresponding to the Office of the "Chairman, Land Surveyors Board" in column 1 and substituting the item "4,000 per sitting";
- (n) in column 2 headed "Salary (annual except as otherwise stated)" by deleting the item "4,000 per day" corresponding to the Office of the "Member, Land Surveyors Board" in column 1 and substituting the item "3,000 per sitting";

- (o) in column 1 by inserting after the item "Member of the Judicial Committee" the item "Chairman, Public Service Disciplinary Board";
- (p) in column 2 by inserting after the item "4,000 per day" the item "4,000 per sitting" corresponding to the Office of the "Chairman, Public Service Disciplinary Board" in column 1;
- (q) in column 1 by inserting after the item "Chairman, Public Service Disciplinary Board" the item "Member, Public Service Disciplinary Board";
- (r) in column 2 by inserting after the item "4,000 per sitting" the item "3,000 per sitting" corresponding to the Office of "Member, Public Service Disciplinary Board" in column 1;
- (s) in column 1 by inserting after the item "Member, Public Service Disciplinary Board" the item "Member, Teaching Service Disciplinary Appeal Board";
- (t) in column 2 by inserting after the item "3,000 per sitting" the item "3,000 per sitting" corresponding to the Office of "Member, Teaching Service Disciplinary Appeal Board" in column 1.

**COMMENCEMENT**

2. This Order shall come into force on the date of its publication in the Gazette.

LIQUOR LICENSING (PROHIBITION)  
ORDER NO. 30 OF 1991

An Order to prohibit the sale and supply of liquor in Vanuatu in the interest of public peace and good order during the general elections.

IN EXERCISE of the powers conferred by section 19 of the Liquor Licensing Act [CAP. 52], I hereby make the following Order:-

**SALE OF LIQUOR IN VANUATU PROHIBITED**

1. Subject to section 2, the sale and supply of alcoholic liquor at licensed premises within the Republic of Vanuatu whether for consumption on or off the premises, is hereby prohibited from 7:30 am on Friday the 29th day of November, 1991 until 7:30 am on Tuesday the 3rd day of December, 1991.

**EXCEPTION**

2. Notwithstanding the provisions of section 1, alcoholic liquor may be sold during the said period within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with their meals.

**COMMENCEMENT**

3. This Order shall come into force on the 29th day of November, 1991.

A R R E T E :

LA VENTE DES BOISSONS ALCOOLISEES EST INTERDITE A VANUATU

1. Sous réserve de l'article 2, la vente et la distribution des boissons alcoolisées dans les débits de boissons de la République de Vanuatu, soit pour consommer sur place ou pour emporter, est par les présentes interdite entre 7h30 du matin le vendredi 29 novembre 1991 et 7h30 du matin mardi 3 décembre 1991.

DEROGATION

2. Nonobstant les dispositions de l'article 1, les restaurants et les hôtels pourront vendre des boissons alcoolisées durant ladite période au cours de leurs heures normales d'ouverture aux clients qui en commandent de bonne foi pour accompagner leur repas.

ENTREE EN VIGUEUR

3. Le présent arrêté entrera en vigueur le 29 novembre 1991.






