



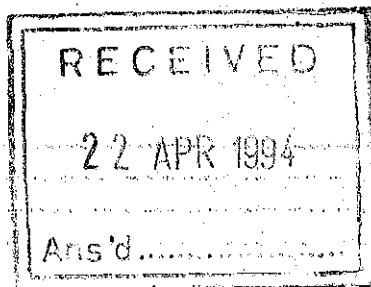

VANUATU NATIONAL PROVIDENT FUND (WITHDRAWAL
OF CREDITS AND SPECIAL DEATH BENEFIT) (REGULATIONS)
(AMENDMENT) ORDER NO. 10 OF 1994

To amend the Vanuatu National Provident Fund (Withdrawal of Credits and Special Death Benefit) (Regulations) Order No. 66 of 1987.

IN EXERCISE of powers conferred on me by section 61(3) of the Vanuatu National Provident Fund Act [CAP: 189], I, WILLIE JIMMY, Minister of Finance and Minister responsible for the administration of the Vanuatu National Provident Fund, make the following regulations:-


AMENDMENT OF REGULATION 9 OF ORDER NO. 66 OF 1987


1. Regulation 9 of the Vanuatu National Provident Fund (Withdrawal of Credits and Special Death Benefit) (Regulation) Order No. 66 of 1987 is amended in subregulation (1) by deleting the figure "50.000" and substituting the figure "100.000".

COMMENCEMENT

2. This Order shall be deemed to have come into force on the 1st day of January, 1992.

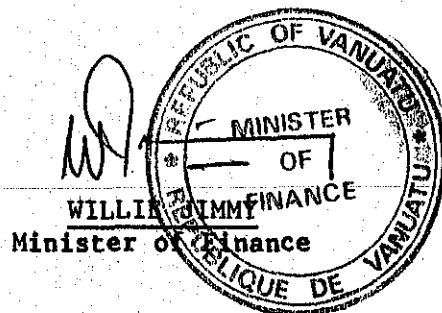
AMENDMENT OF REGULATION 9 OF ORDER NO. 66 OF 1987

1. Regulation 9 of the Vanuatu National Provident Fund (Withdrawal of Credits and Special Death Benefit) (Regulation) Order No. 66 of 1987 is amended in subregulation (1) by deleting the figure "100.000" and substituting the figure "175.000".
